We are principally an e-commerce business so most of our sales will be online and sent through the post. As we will have to hold stock we would also like the opportunity for ad-hoc 'off' sales to local people whilst we are on site and we would also like to do occasional cheese and wine tastings to promote the business. The latter will involve some 'on' site consumption, all of which will occur on the premises. Customers will be able to purchase our products at any hour of the day but we will only 'process' orders for 'off' sales during the hours stated. 'On' sales will only be associated with the cheese and wine events (which are not the core business) and the occasional tasting for wedding planning etc.

However off sales will normally only be available during our normal working hours which will usually be between 8am and 6pm, this is when we will process on-line sales too. Our principle business is on-line and we will be offering fine quality wines and local artisan ciders for off sales. As mentioned earlier in this application we would also like to hold the occasional small scale cheese and wine evenings for small groups of people, maybe around 20. And tastings for wedding planning purposes.

a) General – all four licensing objectives (b,c,d,e)

We are committed to being a responsible seller and aim to fulfill and promote all of the licensing objectives as I hope I have demonstrated in detail in the sections below. We are a small business in a secluded rural location who's core business is the sale of artisan cheese through our e-commerce site (laffinage.co.uk). Alcohol sales form only a very small part of what we do. We will have age restrictions in place for on-line sales of licensable products including age verification to purchase and also receive to goods. We do propose to hold small low key tasting evenings for a limited audience and have an option sell our products to ad hoc customers who visit. We will adopt the 'Challenge 25 policy'. All other measures are listed in detail below. We are just a husband and wife team at this time who are really invested in the success of our business, fulfilling all of the licensing objectives helps promote our commitment to our customers and to the local community.

b) The prevention of crime and disorder

At Manor Farm we have CCTV fitted to the outside of our premises alongside outside lighting.

There will be no opportunity to consume excessive amounts on alcohol on the premises due to the nature of the events we plan to hold, which will only be a few a year.

An incident book will be maintained within which full details of all occurrences of disorder and refused alcohol sales at the premises must be recorded.

Customers will not be permitted to take open containers of alcoholic drinks from the premises.

Customers will not be permitted to bring open or sealed containers of alcoholic on to the premises.

'On' sales to our small tasting events will be by prior appointment and numbers restricted. Any customer believed to be under the influence will not be allowed to attend.

c) Public safety

We will only ever hold small scale tastings at the premises numbering around 20.

There will not be any drinks promotions or 'happy hours' and responsible drinking will be promoted throughout.

We will undertake a risk assessment of the premises prior to inviting customers on to the premises.

All staff will receive appropriate training about emergency and general safety precautions and procedures.

We will ensure that all staff are aware of their social and legal obligations and their responsibilities regarding the sale of alcohol.

Free drinking water will be made available at all times the premises is open to the public.

The telephone numbers of local taxi operators will be available at the premises for the benefit of customers.

There will be no alcohol related litter outside of the premises arising from our events.

The electrical system at the premises, including portable appliances will be inspected and tested annually by a competent person and a satisfactory safety report obtained. A competent person will be a suitably qualified electrician who is registered with the ECA or NICEIC.

All safety certificates and inspection reports will be kept on site and made available for inspection by officers of relevant statutory bodies.

The fire safety measures provided on the premises will be maintained in good working order, and their adequacy will be

determined on a regular basis, by the carrying out of a fire risk assessment as required by, and in accordance with the Regulatory Reform (Fire Safety) Order 2005.

An adequate and appropriate supply of first aid equipment and materials will be available on the premises.

d) The prevention of public nuisance

We will take every reasonable measure to prevent any public nuisance.

As stated earlier in this application we will mostly be selling for off sales on-line. There will be no facility for local off sales to be consumed on the premises or within its immediate vicinity. As part of our introduction to our tastings customers will be made aware of the quiet setting and be asked to be respectful of the local residents during and whilst leaving the event. There will be no loud music and numbers will be limited.

We will keep a refusal/incidence book on site.

For our tasting evenings consumption will be limited to small tasters.

All external doors and windows will be kept shut, other than for access and egress during our tastings to minimise any noise related nuisance to nearby residents and also other users of the site.

The only 'on' sales permitted on site will be during our small low key tastings, the DBS will be on site and monitor

e) The protection of children from harm

We will take every reasonable measure to ensure that children are protected from any harm resulting from our business practices and are always open to advice on how we can improve.

Visitors to the physical premises:

A challenge 21/25 policy will be employed where those individuals visiting the unit who appear to be under the age of 21/25 attempting to purchase alcohol must be asked for identification. The only type of ID that will be accepted is PASS accredited ID, passport or photo driving licence.

Children will only be allowed on the premises if accompanied by an adult.

Online sales:

As part of our commitment not to sell alcohol to those underage customers ordering on-line will be required to enter their date of birth before purchase to prove that they are over 18 years of age. In addition to this an alcohol disclaimer will be displayed on our website advising that a date of birth and the signature of an adult will be required. We will also be running a plug-in that uses Klarna Sofort Ident API which will verify the customer's age by using their bank details.

All parcels sent out containing alcohol will be 'signed for' and the person signing to accept delivery must be able to prove their age.

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. - A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.

We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
