**a) General – all four licensing objectives (b, c, d and e) (please read guidance note 11)**

The 'Boars Head' is a sleepy little Village pub at the end of a lane. We are a 'Food destination' pub charging premium prices. Customers expect the best service and standards at all times. Staff are routinely trained and there is a pro-active management approach throughout each day. To aid an even better 'service' to our guests, we are aiming to install an 'Outside bar'. This will only be used for bottled products, Wines, Spirits and soft drinks. The bar can only be accessed by staff and will be located under the shelter area, directly joined to the main building. Our garden wraps around approximately 40% of the premises and as part of our rostering system, staff are assigned to this area throughout their shift. The outside bar is 6ft x 3ft.

**b) The prevention of crime and disorder**

The main entry into the pub is via the front door with two gated areas for exit from the garden.

We have effective and responsible working practices at all times.

Staff are trained in their legal obligations.

We utilise 'British Institute of Innkeeping' to ensure we utilise best practices.

We accept 'Proof of age cards' in addition to new style driving licences for ID verification.

We have ample lighting both inside and outside our premises.

Guests are required to leave quietly, and notices are in place to remind them.

**c) Public safety**

We are fully Covid secure.

Taxi ordering available, staff contact them for our guests.

Full risk assessments are carried out for any events.

We always have a full complement of staff to deliver our service standards.

All legal requirements are routinely undertaken for fire extinguishers, Gas, Electric etc.

**d) The prevention of public nuisance**

Background music is only played in our premises.

We only serve until 23.00pm.

We supply ample litter bins in addition to hourly litter patrols throughout our premises.

Strict awareness of persons entering and leaving our premises.

Indoor and outdoor lavatories available.

Any off licences are supplied in cardboard containers.

**e) The protection of children from harm**

We do not have gaming or other amusement machines on the premises.

Fact sheets about Alcohol are available for staff.

All beverages are locked away in storage.

We only supply table service of beverages.

We do not undertake any offers such as '2 for 1' or 'Double ups'.



## Notes for Guidance

**This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.**

1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy
2. Describe the premises. For example, the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives. Where your application includes off-supplies of alcohol and you intend to provide a place of consumption of these off-supplies of alcohol, you must include a description of where the place will be and its proximity to the premises.
3. In terms of specific regulated entertainments please note that:
  - Plays: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500.
  - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
  - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
  - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
  - Live music: no licence permission is required for:
    - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
    - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
    - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
    - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
    - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
  - Recorded Music: no licence permission is required for:
    - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
    - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
    - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a

hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
  - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
    - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
    - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
    - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
    - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
