Charfield Neighbourhood Development Plan – SEA Determination

To assist production of the Charfield Neighbourhood Development Plan, South Gloucestershire Council undertook a Strategic Environmental Assessment (SEA) screening opinion. Once this opinion has been consulted on with statutory consultees, it is used to determine whether or not the Neighbourhood Development Plan (NDP) requires a full Strategic Environmental Assessment.

SEA Screening Opinion – South Gloucestershire Council

A pre-submission version of the Charfield Neighbourhood Development Plan, received in September 2019 by South Gloucestershire Council was used to consider the likely environmental effects of the NDP against the criteria set out in Schedule I of the Environment Assessment of Plans and Programmes Regulations 2004. The consideration of likely effects against the Schedule I criteria are available to view in **Appendix 1**.

Following analysis of likely significant effects, South Gloucestershire Council considered that the Charfield Neighbourhood Development Plan was unlikely to have any significant effects on the environment. The initial opinion was that a Strategic Environmental Assessment of the Charfield Neighbourhood Development Plan was not required.

As required by Regulation 9(2) (a) of the Environmental Assessment of Plans and Programmes Regulations 2004, the screening opinion was sent to Historic England, Natural England and the Environment Agency in order to arrive at a determination in consultation with the statutory consultees. The screening opinion was shared with the statutory consultees on the 21st January 2020 and is available to view at **Appendix 1**.

SEA Screening Opinion – Statutory Consultees

All three statutory consultees agreed with South Gloucestershire Councils screening opinion, that the Charfield Neighbourhood Development Plan was unlikely to give rise to significant environmental effects and therefore would not require Strategic Environmental Assessment. The response of Historic England, Natural England and the Environment Agency can be viewed in **Appendix 2**.

Habitat Regulation Assessment Screening Opinion – Natural England

Natural England utilised the information within the analysis of likely significant effects to also determine that the Charfield NDP would be unlikely to give rise to significant environmental effects on European Designated Sites and can therefore be screened out from any requirement for further assessment under the Habitat Regulations. This determination is also available at **Appendix 2**.

Determination

Following the response of the statutory bodies, who agreed with South Gloucestershire Council that the Charfield Neighbourhood Development Plan is unlikely to give rise to significant environmental effects which would require Strategic Environmental Assessment, or have significant effects on European Designated Sites that would require consideration under the Habitats Directive, it has been determined that no further SEA is required. This determination has been arrived at in agreement with relevant statutory consultees.

For the purpose of demonstrating that the NDP is unlikely to have significant effects on the environment; as required by the Neighbourhood Planning (General) (Amendment) Regulations 2015), **Appendix 1**, supported by **Appendix 2** of this document is considered to form the statement of reasons.

Purpose of the Screening Opinion

1. The screening opinion has two purposes:
 - Firstly, to determine whether the Charfield Neighbourhood Development Plan (CNDP) is likely to have significant environmental effects and require strategic environmental assessment (SEA).
 - Secondly, to determine whether the plan has potential negative or uncertain effects on Natura 2000 sites of relevance, which would require further consideration under the Habitat Regulations.
2. This screening opinion has been produced by South Gloucestershire Council, in accordance with the Environmental Assessment of Plans and Programmes Regulations 2004 and Habitat Regulation 2010.
3. As required by Regulation 9(2)(b) of the Environmental Assessment of Plans and Programmes Regulations 2004, and Habitats Regulation (2010), the screening opinion is required to be reviewed by the statutory consultation bodies¹ with a five week period allowed for response, in order for the Council to arrive at a determination, in consultation with the statutory consultees. The consideration of likely environmental effects, against the criteria in Schedule I, (of the Environmental Assessment of Plans and Programmes Regulations 2004), is set out in Appendix 1 of this screening opinion.

Assessing Likely Effects

4. A draft of the CNDP, received by the council in December 2019 has been utilised to consider the likely environmental effects, and effects on Natura 2000 sites of relevance. This version of the Neighbourhood Plan has been supplied alongside this Screening Opinion.
5. In considering likely effects, baseline data and findings within the Sustainability Appraisals of the Core Strategy (2013) and the Policies Sites and Places Plan (2017) have been used, where they relate to the CNDP area. The Habitat Regulations screening opinion has been informed by the conclusions of the Core Strategy Habitat Regulation Assessment (2011) and Screening Determination of the Policies, Sites and Places Plan.
6. In addition to this information, the most current and available data for certain environmental issues were considered as the basis for the screening opinion.

Flood Risk

7. A number of studies have taken place to determine the extent and vulnerability of flood risk in and around Charfield. The primary studies of relevance in this screening opinion were:
 - Environment Agency National Flood Zone data;
 - South Gloucestershire Council Level 1 Strategic Flood Risk Assessment (February 2009); and
 - South Gloucestershire Council Level 2 Strategic Flood Risk Assessment (December 2011).
8. The Charfield Neighbourhood Plan does not make any allocations within the plan for housing, however does set out specific development and design standards. These standards seek to minimise any potential increase in surface water run off as a result of additional development within the CNDP area.
9. Although the policies within the CNDP do not identify new development areas they do attempt to ensure that development and the existing community are safe, that development does not increase flood risk elsewhere and, where possible, reduces flood risk overall.

Heritage and material assets

10. The South Gloucestershire Historic Environment Record contains regularly maintained and updated information on:
 - Conservation Area boundaries;
 - Article 4 directions;
 - Registered Parks and Gardens both nationally and locally designated; Scheduled Ancient Monuments; and
 - Listed Buildings.
11. The record also has information on undesignated assets, such as known archaeology and non-designated above ground heritage assets.
12. The CNDP does not seek to adopt a specific policy for heritage assets however development affecting these assets will be subject to policies currently in the adopted Local Development Plan for South Gloucestershire. These include the Policies, Sites and Places Plan policy PSP17 Heritage Assets and the Historic Environment, as well as the Core Strategy Policy CS9 Managing the Environment and Heritage. The CNDP does include Policy 002 Appearance of Dwellings and Policy 005 Housing Density which seek to protect the rural character of the village and will therefore act to protect the rural setting of heritage assets. These policies are not expected to create further negative impacts over and above the adopted policy already assessed through the SA process. In some cases CNDP policy is expected to add detail to Local Plan policy already adopted to protect and enhance local assets.

Nature Conservation

13. The Local Authority holds information on the following sites of nature conservation:

- International designations: Special Protection Areas, Special Areas of Conservation and Ramsar Sites
 - National Designations; Sites of Special Scientific Interest (SSSI)
 - Local Sites of Nature Conservation Interest
14. This has been supplemented by confidential data on protected species, habitats and related information held by South Gloucestershire Council.
15. The CNDP area will cover the Charfield Parish boundary which, at its closest edge, is over 10 kilometres from the Severn Estuary Natura 2000 site. The policies proposed within the CNDP are not considered to create further negative impacts over and above policies already adopted through South Gloucestershire's development plan which has already been assessed through the SA process.

South Gloucestershire Council - Screening Opinion

16. The consideration of likely environmental effects, against the criteria in Schedule I, is set out in Appendix 1 of this screening opinion.
17. From the analysis of likely effects South Gloucestershire Council considers policies to support a wide range of issues within the CNDP, are:
1. Unlikely to have any significant environmental effects. Therefore Strategic Environmental Assessment of the Charfield Neighbourhood Development Plan is **not required**.
 2. It has also determined that no significant negative or uncertain effects on the Severn Estuary SPA/SAC/ Ramsar site arise as a result of this Neighbourhood Plan. Therefore the CNDP can be **screened out** from further consideration under the Habitat Regulations.
18. **Please can you provide support or objection on this initial screening opinion, so a determination on the need for full SEA can be given.**

These policies are considered to maintain and add local direction to the overarching policy approaches set out in South Gloucestershire's adopted development plan.

Policy 001 and 006 reflect Core Strategy Policy CS8 Improving Accessibility. These policies add further detail to the objectives of promoting alternative means of travel or reducing the need to travel.

Policy 002 and 003 reflect Core Strategy Policy CS1 High Quality Design and CS3 Renewable and Low Carbon Energy Generation. These policies also add detail to Policies, Sites and Places Plan (PSP) Policy PSP6 Onsite Renewable and Low Carbon Energy.

Policy 015 adds detail to CS policy CS2 Green Infrastructure and identifies a specific local project which can help improve Green Infrastructure provision over the plan period.

Policy 018 and 019 are considered to add a level of detail to adopted PSP Policies PSP44 Open Space, Sport and Recreation and CS Policy CS24 Green Infrastructure, Sport and Recreation Standards.

Policy 020, 021 and 022 add further detail to PSP policies PSP6 Onsite Renewable and Low Carbon Energy and PSP21 Environmental Pollution and Impacts.

Policy 023 and 027 add detail to PSP Policy PSP3 Trees and Woodland for the provision of tree planting and also supports the objectives set out in policies PSP1 Local Distinctiveness, PSP2 Landscape and CS1 High Quality Design.

The plan does not allocate any sites for development and instead seeks to add detail to development management policies already in place. The Plan is therefore not considered to have potential effects, significant or otherwise on nature conservation assets. And therefore does not warrant more detailed consideration through either Strategic Environmental Assessment or Appropriate Assessment, under the Habitat Regulations.

Heritage considerations

The CNDP area includes several Listed Buildings including the grade I listed St James Church. The area also includes a large number of locally listed and undesignated heritage assets.

The plan does not propose any site allocations and so the impact on heritage assets is considered to be limited. The plan does not include specific heritage policies and so considerations of these matters would be left to the adopted Core Strategy and Policies, Sites and Places Plan policies CS9 Managing the Environment and Heritage and PSP17 Heritage Assets and the Historic Environment. The CNDP does include Policy 002 appearance of Dwellings which seeks to protect the rural environment and local character of Charfield.

The adopted Policy Framework within the Core Strategy and PSP Plan, along with the NPPF will ensure any applications arising from allocated sites will be sited and designed to mitigate potential for effects, on the setting of listed buildings within Charfield Neighbourhood Plan area.

The plan through its policies is considered to create a further level of detail and positive approach to the consideration of heritage and cultural assets of value and vulnerability within the plan area.

It is not considered that the plan creates the potential for significant negative effects on historic, cultural or material assets that would warrant SEA.

Thank you for your consultation on the above dated 21 January 2020 which was received by Natural England on 21 January 2020

Screening Request: Strategic Environmental Assessment

It is our advice, on the basis of the material supplied with the consultation, that, in so far as our strategic environmental interests (including but not limited to statutory designated sites, landscapes and protected species, geology and soils) are concerned, that there are unlikely to be significant environmental effects from the proposed plan.

Neighbourhood Plan

Guidance on the assessment of Neighbourhood Plans, in light of the Environmental Assessment of Plans and Programmes Regulations 2004 (as amended), is contained within the [National Planning Practice Guidance](#). The guidance highlights three triggers that may require the production of an SEA, for instance where:

- a neighbourhood plan allocates sites for development
- the neighbourhood area contains sensitive natural or heritage assets that may be affected by the proposals in the plan
- the neighbourhood plan may have significant environmental effects that have not already been considered and dealt with through a sustainability appraisal of the Local Plan.

We have checked our records and based on the information provided, we can confirm that in our view the proposals contained within the plan will not have significant effects on sensitive sites that Natural England has a statutory duty to protect.

We are not aware of significant populations of protected species which are likely to be affected by the policies / proposals within the plan. It remains the case, however, that the responsible authority should provide information supporting this screening decision, sufficient to assess whether protected species are likely to be affected.

Notwithstanding this advice, Natural England does not routinely maintain locally specific data on all potential environmental assets. As a result the responsible authority should raise environmental issues that we have not identified on local or national biodiversity action plan species and/or habitats, local wildlife sites or local landscape character, with its own ecological and/or landscape advisers, local record centre, recording society or wildlife body on the local landscape and biodiversity receptors that may be affected by this plan, before determining whether an SA/SEA is necessary.

Please note that Natural England reserves the right to provide further comments on the environmental assessment of the plan beyond this SEA/SA screening stage, should the responsible authority seek our views on the scoping or environmental report stages. This includes any third party appeal against any screening decision you may make.
