**a) General – all four licensing objectives (b, c, d and e) (please read guidance note 11)**

1. The event will take place within an enclosed area
2. For any ‘large event’ with over 2000 people in attendance an event management plan will be submitted to South Gloucester Council

**b) The prevention of crime and disorder**

1. Security and stewards manage the entrances
2. Security will monitor the bars (visually and on radio request by staff) and any attendees exhibiting socially disruptive behaviour due to alcohol consumption will be identified and may be asked to leave.
3. Security and stewards will be positioned in both static and roaming positions throughout the site. Security will be briefed to look for any suspicious activities that may lead to crime and disorder. Radios will be used between the management, security and stewards to ensure a line of contact at all times.
4. The event employs a “zero tolerance drugs” policy. Anyone suspected of using, or found dealing an illegal substance as defined in the Psychoactive Substances Act 2016 may be ejected from the premises and police may be notified.

**c) Public safety**

1. Agree an event safety plan with the relevant officers of South Gloucestershire Council.
2. Qualified professional medical and/or welfare providers will be employed for events over 2000 people.
3. The event risk assessment and fire risk assessment show how the event will minimise the risk from hazards associated with an event of this nature.
4. A clear incident response and evacuation plan will be in position should an incident occur on site.
5. Food traders will be required to provide full safety documentation before the event including information on registration with a local authority.
6. Information will be issued to all staff using radios on a card with a breakdown of which department is contactable on each channel. Traders will be checked that they have the appropriate level of public liability insurance.

**d) The prevention of public nuisance**

1. Residential properties nearby will be taken into consideration during planning.
2. For music focussed events a professional Acoustic Consultant and experienced sound engineer will monitor sound levels within the event to ensure sounds are kept at acceptable levels.
3. Qualified security will be employed to help ensure the prevention of public nuisance.
4. Neighbouring residents and businesses will be informed about any 'large events with the event date and times through a letter posted through their door.

**e) The protection of children from harm**

1. No children under the age of 16 shall be allowed on site unless accompanied by an adult.
2. Arrangements for any lost children shall be in place using Criminal Records Bureau checked staff.
3. All staff shall be trained regarding the law on sales of age restricted products to persons under the age of 18 using the SWERCOTS No Proof of Age No Sale training procedures.
4. In all cases of doubt, photographic ID shall be required.

#### Notes for Guidance

**This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.**

1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy
2. Describe the premises. For example, the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives. Where your application includes off-supplies of alcohol and you intend to provide a place of consumption of these off-supplies of alcohol, you must include a description of where the place will be and its proximity to the premises.
3. In terms of specific regulated entertainments please note that:
  - Plays: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500.
  - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
  - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
  - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
  - Live music: no licence permission is required for:

- a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
- a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
- a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
- a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
- a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
