We will NOT have any visitors to the premises. We will NOT be opening the garage to sell alcohol to any members of the public in-person. The premises license is therefore solely for the purpose of remote alcohol sales (online/mail order) where the alcohol can be dispatched from the garage. When dispatching the alcohol orders, we will require the recipient to be an adult over 18 years-old, using the adult signature feature of our courier service UPS they will have to produce a valid ID.

The garage is locked and the key to the garage will only be kept by a person over 18 years old. The whole household is over 18 years of age and no other visitors under the age of 18 will be allowed to enter into the garage.

There will be NO place for the consumption of alcohol and it will not be permissible to consume alcohol by members of the public in the garage. The main purpose of the garage is to store and dispatch the online/ mail order.

For safety, the garage will have fire extinguishers in the event of fire. There are two doors to the garage therefore there is a reasonable escape route should there be an event of fire. Smoking is prohibited inside the garage.

To ensure that licensing objectives are met under the Licensing Act 2003 for my company to operate a distant on-line/ mail order retail from my premises, both the Premises Licence holder and the Designated Premises Supervisor will adhere to the the policy and conditions as listed below a) the prevention of crime and disorder, b) the prevention of crime and disorder, c) public safety, d) the prevention of public nuisance, and e) the protection of children from harm. This is achieved by working together with the local police force, the South Gloucestershire Council and its officials, together with all responsible authorities to achieve and promote the licensing objectives together. This includes liaising and taking advise from the relevant authorities in conjunction with the South Gloucestershire Council and the police force.

b) The prevention of crime and disorder

- Any persons working in the garage where the alcohol is stored must be over the age of 18.
- The premises will be locked before the close of business to ensure that no individuals outside the company or anyone under the age of 18 will have access to the alcohol.
- A code of conduct will be noted to all those who work in the premises to ensure that it is secure, safe and adhere to the

c) Public safety

- We will periodically (every month) conduct a suitable Fire Risk Assessment at the premises and implement the necessary control measures. This includes:
 - Ensuring fire escape routes is clear and maintained unobstructed;
 - Fire extinguishers are available in the premises;
 - A prohibition on smoking in and around the premises;
 - Flammable liquids are stored correctly away from any sunlight;
 - Notices detailing the actions to be taken in the event of fire or other emergency are prominently displayed and maintained in good condition;
 - Access is provided for emergency vehicles and kept clear and free from obstruction at all times; and
 - Adequate and appropriate First Aid equipment and materials are available on the premises.
- The Designated Premises Supervisor or a Personal Licence holder will be in charge of the premises to ensure that a record of all these checks are kept and can be produced on request.
- An incident record will be kept to record any incidences of injuries in the course of business at the premises.
- Free drinking water will be available at all times.
- We operate a complete no smoking policy at the premises.
- By reducing the number of people working in the garage at any one time (max 4 people) we reduce the risk of injuries and maintaining a record on who is in the garage at any one time.
- All equipments are stored in a identifiable manner.
- We will operate a Health and Safety policy that ensures the moving of parcels or heavy articles are supervised at all times.

d) The prevention of public nuisance

- The company will not operate outside the working hours as specified under this Premises Licence application. The hours are not considered to be anti-social hours and will not produced any noise or vibrations. This is in line with the responsible business hours to minimise any risk of public nuisance.

- The noise management plan has been devised to only allow shipment of alcohol during the day-time working hours as specified in this application.
- Any pick up of deliveries by UPS will be done during the operating hours as specified in this application.
- Doors and windows will be kept closed and regulated to minimize the any noise from within the garage.
- If there is a need for the disposal of empty bottles into waste receptacles outside the premises, it will not be permitted to take place between the hours of 23:00 hrs and 07:00 hrs to minimise disturbance to nearby occupiers.
- The premises and garage is closed to the general public and there will be no consumption of alcohol, therefore no disturbance will be made.

e) The protection of children from harm

- We have a strict policy to ensure that alcohol is only sold to those who are over the age of 18.
- The Designated Premises Supervisor or a Personal Licence holder will be in charge of the premises to ensure that before alcohol are prepared to be dispatched an on-line age verification process check must be completed by customer/ recipient (or those who have ordered the alcohol) is over 18 years old.
- The website in which the alcohol will be sold will have to have an over-18 declaration and ask the customer to verify their age at the point of purchase.
- The company will be using the courier service UPS to deliver the alcohol order. When delivering the alcohol there is an "adult signature verification" service whereby when the parcel is delivered an appropriate and recognized photo ID must be produced by the recipient as a proof of age before the parcel is released.
- Comprehensive training are undertaken by the courier service UPS to ensure that their staff undertaking the deliveries has a age verification in place.
- A signature record will be made available using the UPS service to ensure alcohol is not served to under aged individuals furthering the protection of children from harm objectives.
- The premises (garage) operates a proof of age policy that has been agreed that no one under the age of 18 will be permissible to enter the garage.
- We will note and assist in implementing the crime prevention strategy and advice from the local police force to ensure the protection of children from harm licensing objectives can be furthered and achieved.

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. - A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
