Schedule of proposed opening hours and operating schedule

Proposed Opening Hours

- Every day - 0800 to 2330

Proposed hours for the sale of alcohol on and off the premises

Proposed Operating Schedule

1. The premises shall operate as a shop and café/bistro
2. Locations of fire safety and other safety equipment subject to change in accordance with the requirements of the responsible authorities or following a risk assessment.
3. An appropriate number of first aid kits shall be maintained and available at all times.
4. The premises shall install a cctv system which will:
 - (a) Operate at all times that the premises are open to the public
 - (b) Capture images digitally and will have date and time stamped on them
 - (c) Images to be retained for a period of at least 30 days
 - (d) Cameras must be of sufficient sensitivity to enable them to operate as required under their normal working conditions and lighting levels
 - (e) External cameras should be capable of giving useable images under a variety of weather and lighting conditions
 - (f) Copies of cctv to be provided to the police on request

5. Signs advising customers that CCTV is in operation shall be displayed in prominent locations in the premises
6. The premises will install and maintain a security alarm
7. All of sales of alcohol shall be made in sealed containers
8. The premises will operate a "Challenge 25" policy whereby any person attempting to buy alcohol who appears to be under 25 will be asked for photographic ID to prove their age.
9. The recommended forms of ID that will be accepted are passports, driving licenses with a photograph, photographic military ID or proof of age cards bearing the "PASS" mark hologram, official photographic identity cards issued by EU states bearing a hologram or ultraviolet feature.
10. Suitable and sufficient signage advertising the "Challenge 25" policy will be displayed in prominent locations in the premises.
11. Staff shall receive training in relation to the sale of alcohol commensurate with their duties.
12. Staff training will be refreshed every 6 months.
13. A record of staff training shall be kept on the premises and made available to a designated member of the responsible authorities on request.
14. An incident log shall be kept at the premises, and made available on request to an authorised officer of the council or the police, which will record the following;
 - a. All crimes reported:
 - b. All ejections of patrons
 - c. Any complaints received.
 - d. Any incidents of disorder.
 - e. Seizure of drugs or offensive weapons.
 - f. Any faults in the CCTV system
 - g. Any refusal of the sale of alcohol.
 - h. Any visit by a relevant authority or emergency service.

15. Where home deliveries of alcohol are made the following conditions shall apply:

- (a) Deliveries of alcohol shall only be made to residential dwellings or a place of work with a recognisable postcode
- (b) The premises licence holder shall maintain a record of all delivery companies used and such record shall be made available for inspection by the Police or an authorized officer of the council
- (c) Where Internet /telephone sales are placed, age verification must be obtained before the sale takes place.
- (d) Acceptable forms of ID must be checked on point of delivery and notice of this will be advertised on the company website
