

SOUTH GLOUCESTERSHIRE COUNCIL
(YATE TOWN CENTRE) (PROHIBITION AND RESTRICTION OF WAITING)
ORDER 202(-)

Details of the proposed changes

NOTICE is hereby given that South Gloucestershire District Council proposes to make an order under sections 1(1), 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended the effect of which will be to:

- a) prohibit vehicles waiting at any time in lengths of **A420 Station Road, B4059 Link Road, B4060 Station Road, Bennett's Court, Broadway, Cabot Close, Church Road, Cleeve Road, Elmgrove Drive, Firgrove Crescent, Gleneagles, Highway, Home Orchard, Kennedy Way Car Park, Kennedy Way, Lawns Road, Melrose Avenue, Orchard Close, Painswick Drive, Ridgeway, Stanshawe Crescent, Sundridge Park, Swan Field, The Glen, Tree Leaze, Turnpike Close** and **Walnut Crescent**, Yate; and **B4060 Station Road**, Chipping Sodbury;
- b) restrict vehicles waiting between the hours of 8am and 6pm Monday – Saturday (inclusive) in a lengths of **Church Road, Lawns Road** and **Broadway**;
- c) restrict vehicles waiting between the hours of 8am and 6pm Monday – Friday (inclusive) 2 hours, no return within 4 hours, in a length of **Firgrove Crescent**;
- d) vary further the South Gloucestershire Council (Frome Vale Area - South Gloucestershire) (Prohibition and Restriction of Waiting) (Consolidation) Order 2007, as varied, in so far as it relates to the lengths of road specified in items a) to c) above, the provisions of which will be consolidated into the new order; and
- e) vary further the South Gloucestershire Council (Frome Vale Area - South Gloucestershire) (Prohibition and Restriction of Waiting) (Consolidation) Order 2007, as varied, in so far as it relates to **Kennedy Way, B4059 Link Road** and **The Glen**, the provisions of which will be brought forward unchanged into the new order.

Exemptions in the order permit any vehicle to wait for the purpose of boarding or alighting; loading or unloading goods; delivering postal packets; maintenance of the road; supply of gas, water or electricity; the pursuance of statutory powers or duties; taking in petrol, oil, water or air from any garage; weddings or funerals and in accordance with the current provisions for vehicles displaying a disabled person's badge.
