(YATE TOWN CENTRE - PROTECTION OF SCHOOL ENTRANCES)
(PROHIBITION OF STOPPING) ORDER 202(-)

Details of the proposed changes

NOTICE is hereby given that South Gloucestershire District Council proposes to make an order under sections 1(1), 2(1) to (3), 4(1) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended the effect of which will be to:

- a) protect areas marked with school entrance markings in accordance with the Traffic Signs Regulations and General Directions 2016 in lengths of **Broadway, Church Road, Firgrove Crescent** and **Melrose Avenue**, Yate by prohibiting any vehicle stopping during the restricted hours which will be the hours shown on traffic signs placed at that location; and
- b) vary further the South Gloucestershire Council (Various Roads - Protection of School Entrances) (Prohibition of Stopping) (Consolidation) Order 2012, as varied, in so far as it relates to **St Mary's C of E V A Primary School** and **The Ridge Junior and Broadway Infants School, Town of Yate** therein, the provisions of which will be consolidated into the new order subject to the provisions of item a) above.

Exemptions in the order permit any vehicle to wait for the purpose of building or demolition works; removal of obstruction to traffic; maintenance of the road; supply of gas, water or electricity; the pursuance of statutory powers or duties and fire brigade, ambulance or police purposes.
