Council Tax options for 2021/22

In February 2020 the council approved its 2020/21 revenue budget confirming a general council tax increase of 1.99% along with a 2% precept for adult social care. It also approved outline budgets for the following three years (up to 2023/24) to help it plan for the future.

Following the government's Spending Review on 25th November, the council's preferred option is a 1.99% increase in general council tax and 3% adult social care precept (Option A), as this will lead to the least reduction in spending on services.

This is on the basis that additional savings of around £1.54m per 1% of council tax will need to be found in each year that an increase is not made over and above the savings that the council is already working to deliver.

Please note: the council has no control over the council tax collected on behalf of the Police, Fire Service, or parish and town councils. Each of these bodies will make their own independent decisions.

The council would like your views on the level of council tax the council should consider for 2021/22:

Option A: To increase council tax in 2021/22 by 4.99% (1.99% general council tax and 3% adult social care precept)

This would be an increase of £77.01 per year (or £6.42 per month) for a band D household. This would raise an additional £7.5 million.

Option B: To increase council tax in 2021/22 by 1.99% (1.99% general council tax and 0% adult social care precept)

This would be an increase of £30.71 per year (or £2.56 per month) for a band D household. This would raise an additional £3 million.

Option C: To freeze council tax in 2021/22 at the current level

While the Council is committed to protecting frontline services as much as possible, if council tax is not increased, this would mean further reductions to council services because the current level of service would no longer be affordable. The Council would need to make additional savings of around £3m on top of the £4.6m which have already been identified.
