SOUTH GLOUCESTERSHIRE COUNCIL (PUBLIC FOOTPATH LWB/3/20 AT UWE
HILLSIDE GARDENS SPORTS FACILITY, HAMBROOK) PUBLIC PATH
EXTINGUISHMENT ORDER 2020

This order is made by South Gloucestershire District Council ("the authority") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that footpath described in paragraph 1 below is not needed for public use.

Winterbourne Parish Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situate at Hambrook shown by a continuous bold line on the map attached to this order and described in the Schedule to this order shall be extinguished upon the date of confirmation of this order
2. Notwithstanding paragraph 1 of this order, where immediately before the date on which the footpath is extinguished there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

Description of Public Right of Way Extinguished

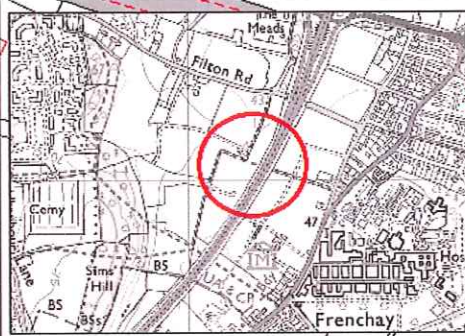
That part of public footpath LWB 3 in the parish of Winterbourne in the Unitary District of South Gloucestershire from its junction with LWB 4 at Point A (grid reference ST 6318 7806) running in an east south easterly direction across an earth bund for a distance of 53 metres to Point B (grid reference ST 6323 7805) where the path is truncated by the M32 motorway. Shown by a solid black line marked A - B on the map contained in this order.

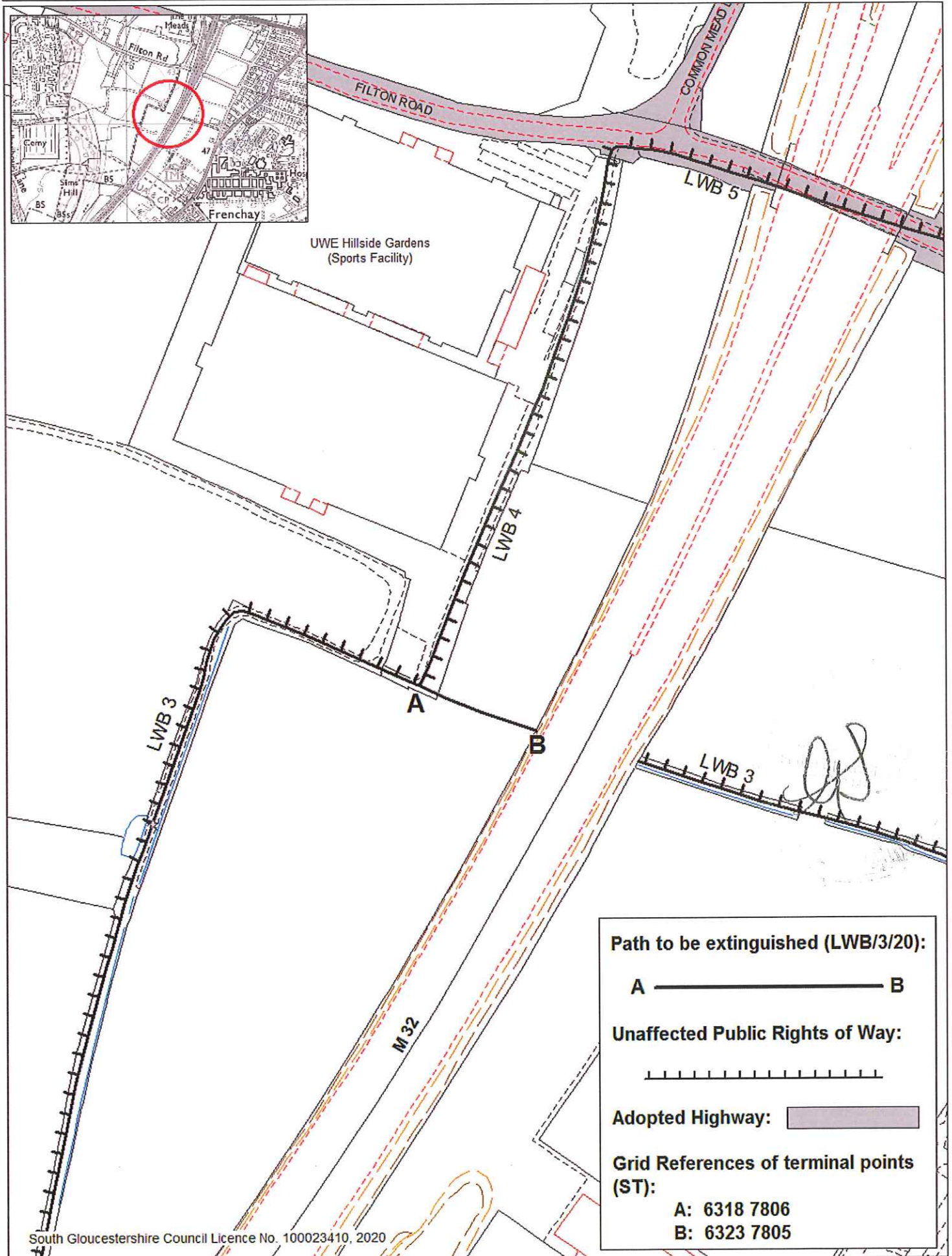
