

**SOUTH GLOUCESTERSHIRE COUNCIL**  
**(VARIOUS ROADS, CHIPPING SODBURY) (PROHIBITION OF WAITING) ORDER 202(-)**

**Details of the proposed changes**

NOTICE is hereby given that South Gloucestershire District Council proposes to make an order under sections 1(1), 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended the effect of which will be to:

- a) remove lengths of no waiting at any time restriction in lengths of **Bowling Hill**, Chipping Sodbury;
- b) add lengths of no waiting at any time restriction in lengths of **Bowling Hill, Chestnut Drive, Culverhill Road, Elm Close, Highfield Road** and **The Parade**, Chipping Sodbury;
- c) bring forward unchanged the no waiting at any time restrictions in lengths of **Leaman Close** and **Rounceval Street**, Chipping Sodbury; and
- d) vary further the South Gloucestershire Council (Frome Vale Area – South Gloucestershire) (Prohibition and Restriction of Waiting) Order 2007, as varied, in so far as it relates to the lengths of road specified in items a) to c) above, the provisions of which will be brought forward into the new order.

Exemptions in the order permit any vehicle to wait for the purpose of boarding or alighting; loading or unloading goods; delivering postal packets; maintenance of the road; supply of gas, water or electricity; the pursuance of statutory powers or duties; taking in petrol, oil, water or air from any garage; weddings or funerals and in accordance with the current provisions for vehicles displaying a disabled person's badge.

Full details of the proposal are contained in the draft order. If you would like to see a copy of the draft order, a map, any orders to be varied/revoked and a statement of the Council's reasons for making the order, you may do so by visiting Yate One Stop Shop (next to the Leisure Centre), Kennedy Way, Yate during normal opening hours.
