

SOUTH GLOUCESTERSHIRE COUNCIL
(VARIOUS ROADS, STOKE GIFFORD) (PROHIBITION AND RESTRICTION OF
WAITING) (VARIATION) ORDER 201[-]

Details of the proposed changes

NOTICE is hereby given that South Gloucestershire District Council proposes to make an order under sections 1(1), 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended the effect of which will be to:

- 1) vary further the South Gloucestershire Council (Southern Brooks Area) (Prohibition and Restriction of Waiting) (Consolidation) Order 2012 so as to -
 - a) prohibit vehicles waiting at any time, subject to specified exemptions, in the lengths of road specified in Schedule 1 to this Notice;
 - b) prohibit vehicles waiting between the hours of 8 am and 9 am and between 3 pm and 4 pm, Monday to Friday (inclusive), subject to specified exemptions, in the lengths of road specified in Schedule 2 to this Notice; and
 - c) restrict any vehicle waiting, subject to specified exemptions, between the hours of 1 pm and 2 p.m. on Monday to Friday (inclusive), 30 minutes in any 1 hour period in the lengths of road specified in Schedule 3 to this Notice. An exemption will be included in the order for vehicles that display a permit issued by the Council.

Full details of the proposal are contained in the draft order. If you would like to see a copy of the draft order, a map, any orders to be varied/revoked and a statement of the Council's reasons for making the order, you may do so at Bradley Stoke Leisure Centre & Library, Fiddlers Wood Lane, Bradley Stoke, South Gloucestershire during normal opening hours. Buckingham Drive

- both sides - from Sandringham Road north westwards for 15m
- Charles Avenue**
- both sides - from Gatcombe Drive north eastwards for 15m
- Dumaine Avenue**
- north east side - from Ratcliffe Drive north westwards for 17m
- south west side - from Ratcliffe Drive north westwards for 16m
- Elizabeth Crescent**
(north - south spur)
- west side - a) from Gatcombe Drive southwards for 10m
b) from Elizabeth Crescent (east - west spur) northwards for 10m
- east side - a) from Gatcombe Drive southwards for 32m

b) from 17m north west of Elizabeth Crescent to 20m south east of that junction
c) from 60m south east of Elizabeth Crescent south eastwards to and including its cul-de-sac end

- north side - from Harry Stoke Road westwards for 6m
- south side - from Harry Stoke Road westwards for 5m
- Ratcliffe Drive** (eastern spur)
- north west side - a) from 6.5m east of Ratcliffe Drive (northern spur) eastwards for 9m
b) from 13m south west of Fabian Drive to 22m north east of Dumaine Avenue
- south east side - from 15m generally north east of Dumaine Avenue south westwards to 24m south west of Fabian Drive

- north west side - from 34m south west Hatchet Road to 20m south west of Gatcombe Drive
- south east side - a) from 34m south west Hatchet Road to 15m south west of Buckingham Drive
b) from 20m north east of Gatcombe Drive to 15m south west of the said junction

- both sides - from Fabian Drive eastwards for 10m

Proposed 'No Waiting', 8am to 9am and 3pm to 4pm, Monday to Friday (inclusive) (currently unrestricted)

Fabian Drive

- north east side - from 14m south east of Ratcliffe Drive to 20m north of Travers Walk
- south west side - from 14m south east of Ratcliffe Drive to 7m north of Travers Walk

SCHEDULE 3

**Proposed 'Limited Waiting', 1 pm to 2 pm, 30 minutes, No return within 30 minutes
Exemption for Permit Holders (currently limited waiting)**

Gifford Crescent

- east side - from 17m south of Kingsway south westwards to 16m north east of Gifford Crescent (southern spur)
- west side - from 11m south of Lawford Avenue south eastwards to 14m north west of Gifford Crescent (southern spur)

North Road

- south and east side - a) from 156m east of Hatchet Lane to 169 metres east of Hatchet Lane
- b) from 176m east of Hatchet Lane to 191m east of Hatchet Lane
