The whole area shown is already within the boundaries of the Toot Scheduled Ancient Monument and is afforded substantial protection from development.

Further protection is wholly unnecessary. The area shown on the map comprises two distinct areas:

1. The first is a bank along the side of Camp Road. This bank is part of the highway and is therefore incapable of development. The area designated also includes existing tarmacadam drive way which does not seem appropriate as a green space. The public have the right to enjoy this space as part of the highway. The guidance expressly says that it is inappropriate to designate highways as Local Green Spaces.

2. The second area hatched on the attached plan, forms part of my garden. It is physically remote from the first area as it is at least two metres higher and if behind a 2.5 metre retaining wall. It does not form part of the Cassy which is the bank below the wall. It is invisible from the highway and cannot conceivably meet any of the criteria for a local green space. It is remote from the local community. It is a complete mystery how this small area has any significance to the local community. It is part of a much larger section of my garden and is therefore poorly defined. The community cannot see it let alone have access to it. It is not particularly rich in wild life and in so far as it has historical value its Scheduled Ancient Monument status provides a comprehensive set of protections.

This whole proposal is completely misconceived and I will strenuously object to the second area being designated at every stage of the process.
