The Mundy Playing Fields were willed to the town by the second of the recreational benefit of the residents of Thornbury and Poulterbrook was purchased in 2004 for the purpose of providing extra football pitches.
This area of open space is extremely well used with a large amount of play equipment including a recently installed splash pad. Adult fitness equipment has also been provided. It has several public footpaths running through it and provides access to open countryside
It is the home of Thornbury Town Football Club and has two full size pitches, a pavilion and training areas.
The Mundy Playing Fields is also the venue for the very successful Thornbury Carnival and is used annually by Thornbury Running Club for its 'Riverside Rollick'. The area is also used for other various 'ad hoc' events.
