

We wish to receive notification of the timetable for reconsideration of this issue, together with any further representation that can be made.

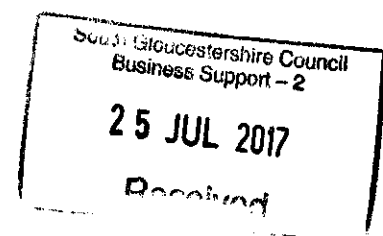

The committee of Hanham District Green Belt Society, which comprises a membership of 120 local households, can see no reason why this site should not remain on the Local Green Space Designation Schedule as by any criteria, the site provides the requirements for registration.


