Text as presented 3.12 South Gloucestershire has a varied and complex landscape which includes the nationally protected landscapes of the Cotswolds Area of Outstanding Natural Beauty (AONB) and the protected habitats of the Severn Estuary, whilst being an important area for growth and economic development.
Comment: This refers to the landscape (singular) of the Cotswolds AONB. With deletion of half of the sentence there is removal of assurance that the PSP plan addresses protection of the Severn Estuary habitats. This protection should be considered 1) as a direct impact of development on a site and 2) indirect impact from consequence of development elsewhere. Special Areas of Conservation (SACUK0013030) and Special Protection Areas (UK9015022) of the Severn Estuary are subject to protection. "These Conservation Objectives are those referred to in the Conservation of Habitats and Species Regulations 2010 as amended ('the Habitats Regulations') and

Article 6(3) of the European Habitats Directive. They provide a framework which should inform any 'Habitats Regulations Assessments' (which may include an Appropriate Assessment) that a competent authority may be required to make under the legislation referred to above. In addition, they can be used to inform any measures necessary to conserve or restore the European Site and/or to prevent the deterioration or significant disturbance of its qualifying features as required under the provisions of Articles 4(1) and 4(2) of the Wild Birds Directive and Article 6(2) of the Habitats Directive respectively."




