



ROAD TRAFFIC REGULATION ACT 1984

SOUTH GLOUCESTERSHIRE COUNCIL (VARIOUS ROADS CHESWICK VILLAGE, STOKE GIFFORD) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 201(-)

STATEMENT OF REASONS

Background

The new housing development at Cheswick in Stoke Gifford is largely complete but issues have arisen with extensive parking by employees and contractors of the Ministry of Defence Abbeywood Complex and also students and staff from the University of the West of England. This has caused difficulties for residents, pedestrians and other road users due to inconsiderate parking in unsuitable locations. To address this the Council is proposing to introduce waiting restrictions in various roads in Cheswick.

Purpose of Scheme

To introduce no waiting at any time restrictions and limited waiting restrictions to prevent inconsiderate parking in parts of the roads mentioned below. The restrictions are intended to prevent parking at junctions and across pedestrians dropped kerbs. In addition restrictions will be also introduced to prevent parking obstructing the entrances to off-street parking courts and to discourage parking on pavements.
